What is the "Sacrifice Event"?

Members will be able to "sacrifice" their existing Multi-D NFT for a FILM FUND NFT. The sacrificed Multi-D NFTs will be sent to a dead wallet, after which the NFTs will become invalid. This will have a deflationary effect on the Kleks Academy Multi-D NFT Collection and will increase the rarity of the Multi-D NFTs that remain. The Sacrifice Event will last from January 1st -March 31st 2024. A total of 2345 Multi-D NFTs will be open for sacrifice (from the current existing total of 3579 Multi-D NFTs), which means that a minimum of 1234 Multi-D NFTs will remain.



What is the "FILM FUND NFT"?

This a new project we are launching in April 2024. The FILM FUND NFT will be a film fund providing all retail investors the chance to invest into various future film productions from known hitmakers, such as Open Mind Production and others (to be revealed). This will be the first time smaller retail investors will have access to such high profile film projects. The FILM FUND NFT will earn 10% commission from all funds raised. 1/2 of this commission will be distributed quarterly as a dividend payout to all FILM FUND NFT holders. Owners of the FILM FUND NFTs will also have preferential investment terms for all film productions, with up to 2x better returns than investors using our platform without owning the FILM FUND NFT. Only NFT holders will have access to special utilities related to each project (such as visiting the film set, access to unique materials from the film production, and others). There will be a limited amount of FILM FUND NFTs (TBD), most of which will be distributed via the "Sacrifice Event" starting in January 2024.



How will I be able to mint new NFTs with my accumulated Freckle\$?

In April 2024, all Members will have the chance to convert their accumulated Freckle\$ points into Freckle\$ virtual currency. The Freckle\$ currency will be airdropped to holders' wallets. Members will have the option to purchase (mint) new Multi-D NFTs for the price of 12,345 Freckle\$/each on our website. The Freckle\$ currency will also be available for purchase on Decentralised Exchanges (DEXs).



What are the Multi-D NFT Utilities?

Below is a list of all utilities available to all owners of Multi-D NFTs:

- Daily amount of 5 FRECKLE\$ to be released into your FRECKLE\$ meter within a 5 year period.
- At least one bonus release of FRECKLE\$.
- Multiple Discoveries of new rarity traits of Multi-D NFT's (cyclical events as planned in the Academic Roadmap).

Below is a list of special utilities available to owners of select Multi-D NFTs:

- Once in a lifetime opportunity to have a speaking role in a custom scene shot exclusively for the Multi D-NFT owner. Total of 5
- Your Multi-D NFTs can be listed in the credits of the film, boosting their popularity among global viewers. Total of 15
- Access to physically visit the film set and meet the actors and crew during production. Total of 75
- A chance to own real life props and costumes used during the film production. Total of 20
- A special screening night with the film's director explaining the making of specific scenes. Total of 683
- Access to unique materials from the film production. Total of 416
- Dinner with Maciej Kawulski, the director of the film. Total of 5
- One hour in the editing room, witnessing the film director at work. Total of 5
- Tickets to the film premiere. Total of 10

*All utilities listed above will also apply to the third Kleks film.
